**PUBLIC PARTICIPATION ON THE PUBLIC FINANCE MANAGEMENT (AMENDMENT) BILL, 2026 AND THE PUBLIC FINANCE MANAGEMENT NATIONAL /COUNTY GOVERNMENTS) (AMENDMENT) REGULATIONS, 2026**

The National Treasury through a Multi -Agency Taskforce has developed a Draft Public Finance Management (Amendment) Bill, 2026 and Public Finance Management (National Governments) Regulations, 2026. The Bill seeks to strengthen the effectiveness of Internal Audit and Audit Committees across Public entities in Kenya in line with the Zero Fault Audit Initiative.

Pursuant to Articles 10 and 232 of the Constitution of Kenya, 2010, the National Treasury hereby invites members of the Public, Stakeholders, Professional Bodies, County Governments, Public Institutions, and all Interested Persons to submit their views on the Public Finance Management (Amendment) Bill, 2026.
