STATEMENT BY THE CABINET SECRETARY THE NATIONAL TREASURY AND PLANNING

Kenya's long term development blue-print, Kenya Vision 2030, is in its third implementation phase under the Third Medium Term Plan (MTP III) 2018-2022. A total of 28 MTP III Sector Plans have concurrently been prepared through 25 MTP Working Groups and three (3) Thematic Working Groups. The Plans provide in detail policies, programmes and projects to be implemented in each sector for the period 2018-2022. The Plans also incorporate policies, programmes and projects necessary for the effective implementation of the "Big Four" initiatives namely: manufacturing and agro-processing; food and nutrition security; universal health coverage and affordable housing. Ongoing flagship projects and other priority programmes and projects carried forward from the previous Medium Term Plans will also be implemented. The Sector Plans have also mainstreamed key priorities outlined in the Manifesto of the Jubilee Government.

The MTP III and the Sector Plans have been prepared through a participatory and inclusive process involving representatives from the government, development partners, private sector, Civil Society, NGOs, organizations representing vulnerable groups, faith-based organizations and professional associations, among others and in line with the constitutional requirements.

The Sector Plans detail specific programmes and projects for implementation during the plan period, 2018-2022. The programmes and projects outlined in these plans will be implemented in close consultation and collaboration with county governments and in line with the Fourth Schedule of the Constitution. The Public Private Partnerships (PPPs) framework will be the vehicle through which the private sector will contribute to the implementation of programmes and projects highlighted in the plans.

The County Integrated Development Plans, County Spatial Plans and Ministries, Departments and Agencies (MDAs) Strategic Plans (2018-2022) will be aligned to the MTP III and the National Spatial Plan. Implementation of these plans will also be linked to the Results-Based Management Framework through Performance Contracts and Staff Performance Appraisal System.

A robust monitoring and evaluation framework will be put in place. In this regard, National Integrated Monitoring and Evaluation System (NIMES), County Integrated Monitoring and Evaluation System (CIMES) and the electronic Project Monitoring Information System (e-ProMIS) will be fully integrated with other governmental financial systems. This will ensure effective tracking of implementation of programmes and projects and also boost Public Investment Management.

In conclusion, I would like to appreciate the respective Cabinet Secretaries, Chief Administrative Secretaries, Principal Secretaries, staff in the MDAs and all those involved in the preparation of the Sector Plans for their valuable inputs. In addition, I commend staff from State Department for Planning led by Principal Secretary, Planning for the effective coordination of the MTP III preparation process.

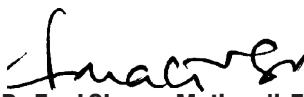
FOREWORD

Maintenance of sustainable peace and security is enshrined in both the Constitution and the Vision 2030 as a basis for supporting achievement of the targeted double digit economic growth. The plan strives to put in place measures that will ensure national security, compliance, utmost respect for the rule of law, democracy, human rights and fundamental freedoms are upheld. This is based on the understanding that security is key to national development through provision of a conducive environment for businesses to thrive as well as encouraging both domestic and foreign investments, tourism and a 24-hour economy. This will in return create more employment for the youth and consequently reduce insecurity in the country.

The third Security Peace Building and Conflict Resolution Sector Plan for the period 2018-2022 constitutes an important performance management instrument in the implementation of the Vision 2030. The implementation of the two previous MTPs has seen Kenya improve in terms of security provision. This Sector Plan was developed through stakeholder participation as enshrined in the Constitution and aims at enhancing security of persons and property in Kenya. It builds on the lessons learnt in the implementation of the previous MTPs to eradicate inter-community conflicts, ensure safe custody of offenders and their effective rehabilitation and re-integration to the society; reduce incidences of piracy; reduce human-wildlife conflicts and reduce influx of refugees and proliferation of illicit small arms and light weapons.

The sector will support strategic government interventions as outlined in the “Big Four” initiative through a secure 24 hour economy which promotes manufacturing, offering a comprehensive medical cover and Group Life Insurance to the security officers and partnering with private sector for decent staff housing. It will also play a key role in promoting alternative measures to environmental conservation, water harvesting and storage through barazas and other forums to enhance food security. Specifically the following projects and programmes will be implemented during the MTP III period: Security Modernization Programme; Equipping of the National Forensic Laboratory; Capacity Building; Staff Welfare Programme with emphasis on housing; Case Management System; Coastal Integrated Surveillance System; Installation of Integrated Surveillance Systems in major towns, along the ports, prison facilities and at national parks; Upgrading security roads and airstrips; Enhancing *Nyumba Kumi* community policing initiative; Modernization of prison industries; Construction of additional prisons; Operationalize food processing factory in Gilgil; Connect secondary data users and other Government Agencies to Integrated Population Registration System (IPRS) among others.

In order to fully achieve the aspirations of the Security MTP III, I call upon all citizens to participate in improving security through the 'Citizens Participating in Security Agenda' as outlined in the *Nyumba Kumi* initiative. I also call upon the Private Sector as well as Development Partners to collaborate with the Government in implementing the targeted programmes and projects so as to achieve the objectives of the Plan and make Kenya a safe hub in the region.

PREFACE

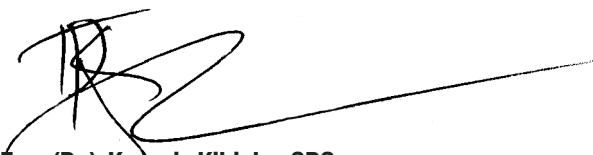

The sector realized several milestones during the MTP II period and these include: security modernization programme, recruitment and capacity building of security officers, and rollout of the group life insurance and medical insurance cover and housing programme for police/prison officers among others.

The preparation of this Sector Plan entailed a comprehensive analysis of the security situation in Kenya. The implementation of the MTP II came during the period when Kenya was experiencing security challenges particularly terrorism. However, concerted efforts by the Government, various stakeholders including development partners helped reverse the situation. The country now enjoys tranquility and key sectors of the economy are now on an upward trajectory.

A situational analysis focusing on the review of the MTP II was carried out with an aim of addressing emerging issues, lessons learnt and challenges. Given the dynamic nature of security, emerging issues and challenges highlighted informed the new programmes for implementation under the MTP III. For successful implementation, the programmes are anchored on legal, policy and institutional reforms as well as the Constitution. A summary of all the programmes along with their budgets are given in the implementation matrix. Proper monitoring and evaluation (M&E) of the planned activities will be regularly done to ensure their full implementation. Reports drawn from the M&E exercises will aid in tracking expenditures as well as inform allocation of resources.

Going forward and ushering in the operationalization of the MTP III, the MDAs within the sector are required to revise and anchor their Strategic Plans to this Plan in order to actualize the planned activities. The overall goal of this plan rides on the overarching objective of the Vision 2030 whose theme is to transform Kenya into “an upper middle-income rapidly industrializing country offering all its citizens a high quality of life in a clean and safe environment” by the year 2030.

I would like to acknowledge the team of officers drawn from various MDAs, the Private Sector and Development Partners who took part in the development of this Security Sector Plan. I also urge all stakeholders to take keen interest to familiarize themselves with this Plan and ensure efficient and effective implementation of the same.

EXECUTIVE SUMMARY

The Kenya Vision 2030 defines security as a society free from danger and fear with emphasis on security of persons and property. Security is crucial for the achievement and sustainability of the Kenya's projected double digit annual economic growth rate by the year 2030.

The role of the sector in the country's transformation and economic development aims at enhancing the capacity of the state to protect its citizens and property from both internal and external threats while maintaining its territorial integrity and sovereignty. The government has continued to invest in security through a modernization programme for security agencies which has resulted in drastic reduction of security threats. As a result, Kenya has continued to enjoy moderate economic growth compared to many developing countries in the region.

The security sector comprises of the following Ministries, Departments and Agencies (MDAs): Ministry of Interior and Coordination of National Government; Ministry of Defense; National Intelligence Service (NIS); National Authority for the Campaign against Alcohol and Drug Abuse (NACADA); Kenya International Boundaries Office (KIBO); Kenya Wildlife. Other key stakeholders include: the Office of the Attorney General, Office of the Director of Public Prosecution, the Judiciary among others.

During the MTP II period (2013-2017), the Sector addressed issues of national security with special emphasis on reforms and modernization of security equipment both hardware and software. Some of the notable achievements include: provision of comprehensive insurance cover and medical insurance to security officers; Enactment and operationalization of the National Government Coordination Act, 2013; Installation of National Security Communication Network and the Surveillance System in Nairobi, Mombasa and their environs; construction of the National Forensic Laboratory among others.

The key emerging issues within the sector that require attention include; emerging forms of crime including cyber-attacks and internet bullying. Insecurity remains a major challenge and continues to pose a significant burden on doing business in the country. The Security Sector has identified programmes and projects aimed at improving security situation in the country and in the region.

During the MTP III, the Sector will implement the following programmes and projects: Installation of Surveillance Cameras in Nairobi & Mombasa Metropolis, Nakuru, Eldoret and Kisumu; Equipping of the National Forensic Laboratory; Enhancement of police communication system; Acquisition of an Integrated Case Management System; Construction and equipping of National Police Service (NPS) Hospital; Construction of 20,000 police and 6,000 prison staff houses and 100 new prison wards; Completion and equipping of the 6 model prisons facilities; Installation of phase II of the Integrated Population Registration System (IPRS); Modernization of the Police Air wing; and Promotion of national, regional and international peace.

The sector will support the "Big Four" initiatives through issuance of visas, passports and work permits to improve expertise in Manufacturing, Health, Food Processing and Building and Construction. Food processing factory in Gilgil will also be operationalized.

The total estimated cost of the sector programmes over the Plan period is Kshs. 456.865 Billion. The government is expected to meet the larger share in the implementation budget of these projects, while Development Partners, the Private Sector, Civil Societies and Faith Based Organizations are expected to contribute under the Public Private Partnership Act No. 15 of 2013. The sector will also establish flexible and efficient Governance structures to enable smooth flow of feedback as well as allowing the non-state actors to participate in the monitoring and evaluation of the programmes and projects.

1.0 INTRODUCTION

1.1 Overview

National security is paramount in the achievement of a country's sustainable economic growth. The Government is therefore committed to creating a secure environment which is a key incentive for attracting both domestic and foreign investments.

The Security Sector envisions a "*society free from danger and fear.*" Freedom from danger (protection from physical or direct violence) and freedom from fear (a sense of safety and overall well-being) provide an enabling environment for individuals and businesses to prosper. Secure environment brings forth peace and stability which are also pre-requisites to social and economic development. The preservation of national security and sovereignty underscores the desire to advance national interests by guaranteeing a secure socio-economic and political environment for sustainable economic growth. During the MTP III, the sector will implement projects/ programmes that will enhance realization of Government strategic interventions on increased manufacturing, enhanced agro-processing, affordable housing and universal health coverage.

On the regional front, the Great Lakes Region countries have for the past two and a half decades experienced conflicts and instability which have impacted negatively on regional development efforts due to influx of refugees and proliferation of illicit small arms and light weapons. Kenya remains a strong champion of peace and political stability in the region and collaborates with regional institutions such as Inter Governmental Authority on Development (IGAD), East Africa Community (EAC), International Conferences on the Great Lakes Region (ICGLR) and African Union (AU).

2.0 SITUATIONAL ANALYSIS

This section provides an overview of the security situation in the country over the MTP II period. It also highlights the sector targets, achievements and gaps of the Security Sector over the same period.

2.1 Overview of Security Situation in Kenya

The MTP II period experienced lower than the targeted economic growth in many sectors, in particular the tourism industry due to security threats, especially terrorist attacks. However, following concerted efforts by the government, the private sector and development partners, the situation significantly improved. The government has continued to invest in security through modernization programme for security agencies as well as capacity building and intelligence sharing. This is aimed at enhancing capacity to protect the country from both internal and external threats while maintaining its territorial integrity, peace, stability and prosperity. The key sector priorities outlined in the MTP II included: Promotion of sustainable peace and security, Maintenance of law and order, Deterring and defending the country against external aggression; Deepening policy, legal and institutional reforms; Eradication of alcohol, drug and substance abuse; Curbing proliferation of small arms and light weapons; Tightening border surveillance; Scaling of fight against wildlife crimes; enhancing collection, analysis and dissemination of up to date intelligence information.

The insecurity experienced in some parts of the Horn of Africa and the Great Lakes Region remained a challenge to the country's security. This makes Kenya's role in the search for peace, security and sustainable development a priority in foreign policy. Kenya played a leading role in conflict resolution in Burundi, Central African Republic, Democratic Republic of Congo, Somalia and South Sudan.

The region was confronted with challenges of evolving threats such as terrorism, organized crime, piracy, cybercrime, influx of refugees and the proliferation of Small Arms and Light Weapons (SALWs) as well as human and drug trafficking. The expansion of internet access, ease of travel, and the growing sophistication of extremist and criminal groups made threats increasingly transnational and requiring a collaborative response. Kenya attaches great importance to maritime safety and security and remains at the forefront in forging regional and global partnerships to ensure its security and thereby facilitate sustainable exploitation of marine resources. With the entry of Kenya Defence Force (KDF) in Kismayu in 2011 cases of piracy in Kenyan waters have drastically reduced. Kenya is also a key member of the Contact Group on Piracy off the Coast of Somalia (CGPCS) and a co-chair of Working Group 1 that focuses on capacity building. The Contact Group comprising international and regional actors established a large focused framework for cooperation to rid the area of piracy.

Kenya is yet to complete ratification of its boundaries agreements with neighboring countries. The completion of the process of delimitation and demarcation of international boundaries will lead to ratification and depositing of the relevant documents and maps with the African Union (AU) and the United Nations (UN).

2.1.1 Key Achievements of the MTP II (2013-2017)

The sector realized a number of achievements in the MTP II period. Key among them:

- a) Enhanced security: Security was improved through the installation of National Security Communication Network and the Surveillance System in Nairobi, Mombasa and their environs; installation of 1850 CCTV cameras in Nairobi, Mombasa and its environs; construction of 49 sub

- county headquarters; recruitment of 700 Assistant County Commissioner's; completion of the construction of the National Forensic Laboratory; connection of 171 agencies to IPRS including KRA, HELB, NHIF, major banks and other financial institutions, all telephony and mobile money transfer companies and all Credit Reference Bureaus; hosting of the ICGLR Youth Summit on Youth unemployment ; installation of 3,000 CCTV cameras in major towns and 530 street lights within NMR and in all 47 county headquarters and satellite towns; installation of six (6) high masts in Garissa town and thirteen (13) in Nakuru town; and initiating feasibility studies for street lights and high mast for Kakamega, Garissa and Kericho; National Police Service Amendment Act, 2014; National Police Service Commission Amendment Act, 2014; National Security Amendment Act, 2014 and establishment of the Private Security Regulatory Authority.
- b) Improved police and prison officers' welfare: This was done through acquisition of 3,071 housing units for National Police Service and 590 for the Kenya Prisons Service and provision of comprehensive insurance cover and medical insurance.
 - c) Improved the management of offenders: This was achieved through: Construction of 18 new prisons across the country to decongest the existing facilities; establishment a girls' borstal institution at Kamae, Kiambu County; and the establishment of the Integrated National Offender Records Management System for the non-custodial offenders; Enactment Transfer of Prisoners Act, 2015; Persons Deprived of Liberty Act, 2014; and Development National Correctional Policy; Prisons Act amendment 2015.
 - d) Enhanced registration and immigration services: Constructed immigration and registration offices in Kisii, Nyeri, Lwakhakha, Bungoma, Masaba North and Kilifi. Installed e-Passport system and e-Visa system; Installed e-Foreign national management system (e-FNMS); Implemented a tripartite Memorandum of Understanding between Uganda, Rwanda and Kenya that has enabled Kenyans to travel to Rwanda and Uganda using their National Identity cards; Implemented a tripartite agreement between Kenya, Rwanda and Uganda for the use of East African Single tourist visa.
 - e) Improved disaster preparedness and mitigation: Acquired and deployed 51 fire engines to 17 County Governments; trained staff in 28 counties on safety of buildings; acquired and deployed to counties two multipurpose ambulances with fire extinguishing capabilities, four land rovers equipped with modern fire-fighting equipment and one (1) 56 metre turn table aerial; Developed the National Disaster Management Policy.
 - f) Enhanced National Regional and International peace: Enacted and operationalized the National Government Coordination Act, 2013; reviewed the Sessional Paper No. 8 of 2013 on National Values and Principles of Governance and Sessional Paper No. 9 of 2013 on National Cohesion and Integration; carried out GIS mapping of cross-border conflicts in Karamoja and Somali Clusters; established a Technical Cooperation Fund to advance Kenya's influence in the region; and established a Regional Cooperation programme to cooperate with East Africa Standby Force (EASF). Established five (5) new diplomatic missions in Algiers, Luanda, Mogadishu, Havana and the United Nations Office in Nairobi.

Kenya was elected a member of the Africa Union Peace and Security Council (AUPSC) for a three year period; Signed and implemented a Tripartite Agreement with the Government of the Federal Republic of Somalia and the United Nations High Commissioner for Refugees (UNHCR) governing the voluntary repatriation of Somali refugees living in Kenya; Established the Kenya National Committee on the Prevention of the Crime of Genocide, War Crimes and Crimes Against Humanity and All Forms of Discrimination.

3.0 EMERGING ISSUES, CHALLENGES AND LESSONS LEARNT

3.1 Emerging Issues

- (i). Sophisticated and changing forms of cybercrime, terrorism and poaching;
- (ii). Increased incidences of radicalization and extremism;
- (iii). Domestic and gender based violence

3.2 Challenges

- (i). Continued radicalization, recruitment and indoctrination of Kenyans especially youth into terror organizations and proscribed groups;
- (ii). Increased ecosystem interruption leading to human wildlife conflict ;
- (iii). Domestic and gender based violence;
- (iv). Persistent encroachment of public land.
- (v). Cross-border conflicts and regional instabilities especially in Somalia and South Sudan;
- (vi). Porous borders; proliferation of illicit arms and light weapons and influx of refugees and aliens;
- (vii). Persistent resource based conflicts due to climate change, leading to cattle rustling and banditry;
- (viii). Increasing levels of poverty, unemployment and widening inequality making Kenyans especially the youth vulnerable to commit crime;
- (ix). Inadequate funding for various projects and programmes including infrastructure, houses for security officers, human resource development and research among others in the sector;
- (x). Resettlement of IDPs;
- (xi). Congestion at the police and prison staff houses resulting to psychological related problems;
- (xii). Unresolved international land and maritime border issues;
- (xiii). Ageing security infrastructure and equipment;
- (xiv). Poaching and illegal logging in forests;
- (xv). Increased cases of alcohol, drug and substance abuse especially among the youth leading to increased crime incidences;
- (xvi). Lack of an integrated digitized data system in the entire criminal justice system;
- (xvii). Lack of adequate policy, legal and institutional framework to fully operate especially in relation to Coastline security and management of blue economy resources; and
- (xviii). Unintegrated population and registration systems.

3.0 Lessons Learnt

- (i). Sustainable funding and technical assistance to AMISOM operations in Somalia is key towards combating terrorism;
- (ii). Adequate financial and political support is key towards creating and sustaining requisite momentum for resolving endemic regional conflicts;
- (iii). Enhanced specialized training and use of technology by security agencies is key in addressing emerging forms and changing trends of crime;
- (iv). Community involvement in improving security and conflict management leads to sustainable peace and stability;
- (v). Youth engagement in productive economic activities is critical in fighting crime;
- (vi). Stakeholders' engagement is very critical in projects' preparation and implementation for ownership and sustainability.
