

# THE NATIONAL TREASURY & ECONOMIC PLANNING MONTHLY DEBT BULLETIN APRIL 2023

#### I.I Introduction

The total nominal public and publicly guaranteed debt stock as at end of April 2023 was Kshs. 9,634.14 billion (66.3 percent of GDP¹). Domestic debt stock was Kshs. 4,541.64 billion (31.3 percent of GDP), equivalent to USD² 33.42 billion, while the external debt stock was Kshs. 5,092.50 billion (35.1 percent of GDP), equivalent to USD 37.47 billion. Domestic and external debt stock accounted for 47.1 percent and 52.9 percent of total debt stock, respectively.

# I.2 Movement in Exchange Rates


Kenya's public and publicly guaranteed debt is denominated in five major currencies, namely the USD, Euro, Yen, Yuan and Sterling Pound. During the month under review, the Kenya shilling depreciated against the USD, Euro, Yen, Yuan and Sterling Pound by 2.7 percent, 3.7 percent, I.8 percent, I.9 percent and 3.5 percent respectively. The base<sup>3</sup> exchange rates for the aforementioned five currencies, notably the USD, Euro, Yen, Yuan and Sterling Pound were Kshs. I32.33, Kshs. I44.37, Kshs. 99.63, Kshs. I9.25 and Kshs. I63.67 respectively.

# 1.3 Size of Public and Publicly Guaranteed External Debt

Overall, the National Government's external debt stock increased by Kshs. 241.41 billion from Kshs 4,851.09 billion in March 2023 to Kshs. 5,092.50 billion in April 2023. This was attributed to disbursements made during the month and the exchange rate depreciation. Debt owed to bilateral creditors increased by Kshs 29.95 billion from Kshs. 1,198.99 billion to Kshs. 1,228.94 billion while multilateral debt increased by Kshs. 165.27 billion from Kshs. 2,244.09 billion to Kshs. 2,409.36 billion. Commercial debt increased by Kshs. 42.35 billion

from Kshs. 1,238.14 billion to Kshs. 1,280.49 billion during the same period. Publicly guaranteed external debt marginally increased by 3.84 billion from Kshs. 169.87 in March 2023 to Kshs. 173.71 billion in April 2023.

#### I.4 Movement of Domestic Debt

The domestic debt stock increased by Kshs. 2.05 billion from Kshs. 4,539.59 billion in March 2023 to Kshs. 4,541.64 billion in April 2023. Treasury bills increased by Kshs. 0.02 billion from Kshs. 665.86 billion to Kshs. 665.88 billion whereas treasury bonds increased by Kshs. 10.40 billion from Kshs 3,771.03 billion to Kshs 3,781.43 billion during the same period. Others include tax reserve, Government overdraft at the Central Bank of Kenya and bank advances decreased by Kshs 8.38 billion from Kshs. 102.71 billion to Kshs 94.33 billion during the same period.

# 1.5 Currency composition of external debt

The proportion of external debt denominated in USD, Euro, Yen, Yuan and Sterling Pound was at 66.8 percent, 20.9 percent, 4.3 percent, 5.4 percent and 2.4



percent respectively. Other currencies<sup>4</sup> accounted for 0.2 percent of total external debt (Chart 2). The Government is currently exercising currency diversification with an aim of mitigating the exchange rate risk on external debt.

#### I.6 Actual Cumulative External Debt Service


The actual cumulative external debt service as at end April 2023 was Kshs. 334.55 billion against a target of 362.28 billion. External debt service during the month of April 2023 was Kshs. 21.92 billion, comprising principal and interest payments of Kshs. 17.51 billion and Kshs. 4.41 billion respectively. Debt service to bilateral creditors accounted for 41.8 percent of the total cumulative debt service while commercial, multilateral creditors and guarantees accounted for 37.3 percent, 17.2 percent and 3.7 percent, respectively.

#### 1.7 Domestic Borrowing

During the month of April 2023, Government securities amounting to Kshs. I56.00 billion were advertised. Bids worth Kshs. I21.19 billion were received, comprising of Kshs. I05.17 billion and Kshs. I6.02 billion Treasury bills and bonds respectively. Bids worth Kshs. I11.20 billion were successful, out of which Kshs. I00.97 billion and Kshs. I0.23 billion were Treasury bills and bonds respectively. The monthly redemptions amounted to Kshs. 99.70 billion, of Treasury bills.

(Chart 3). In aggregate, the exchequer had a surplus of Kshs. II.50 billion during the month.

Chart 3: Government Securities Performance from April 2022 to April 2023 in Kshs. Billions



# 1.8 Domestic Debt by Instruments

As at the end of April 2023, the ratio of bonds to bills was 83:15. The Government overdraft at the Central Bank of Kenya, Tax Reserve Certificates and bank advances accounted for 2 percent of domestic debt during the same period (Chart 4).

# 1.9 Net Domestic Financing

The net domestic financing as at end of April 2023 was Kshs. 261.39 billion against an annual target of Kshs. 478.15 billion for FY 2022/23.


# 1.10 Cumulative Domestic Interest Payments

As at end of April 2023, the actual cumulative domestic interest payment amounted to Kshs. 422.35 billion against a cumulative target of 537.38 billion. Interest payments for Treasury bonds and bills in the month of April amounted to Kshs. 43.55 billion and Kshs. 4.58 billion, respectively. The interest payment on the overdraft was Kshs. 0.62 billion.

# I.II Average Interest rates for Treasury Bills

On average, there was a marginal change in interest rate for Treasury bills during the month. The average interest rates for 9I-day, 182-day, and 364-day Treasury bills increased to 10.04 percent, 10.42 percent and 10.91 percent in April 2023 from 9.76 percent, 10.25 percent and 10.75 percent in March 2023, respectively as shown in Chart 5.


The average interest rates for the 91-day, 182-day and 364-day Treasury bills increased by 28, 17 and 16 basis points, respectively.

### 1.12 Government Securities Yields

The interest rates have been on the rise both in the international capital markets and domestic market following monetary policy tightening by the Central Banks both in the advanced and developing economies to contain inflationary pressures.

The 9I Day Treasury bill interest rates has increased from 6.9 percent at end June 202I to 10.3 percent as at end April 2023 (a 304 basis points increase) as shown in Chart 6.

# 1.13 Average Time to Maturity for Treasury Bonds

The Average Time to Maturity (ATM) for Treasury Bonds during the month of April 2023 was 8.9 years.

# I.14 Sovereign Credit Rating

Kenya was assigned a B sovereign credit rating by Standard & Poor's (S&P) and Fitch in 2006, and 2007, respectively. It was assigned a B+, equivalent of BI rating by Moody's in 2012, which was the only rating agency to upgrade Kenya's sovereign rating to B2 in 2018. S&P did cut Kenya's ratings outlook from stable to negative. While Fitch credited Kenya at B with a stable outlook and B2 with a negative outlook by Moody's (Annex I). The variations in the credit rating scores of the three agencies shows the influence of subjectivity and the perceptions generated in the qualitative analysis.

In order for Kenya to graduate to investment grade (BBB-) and attract cheaper debt from global markets, there is need for: actualizing the long planned fiscal consolidation; improvement of export sector performance and expand foreign reserves accumulation; promotion of economic growth to boost GDP per Capita; and improve on food production, access and affordability in order to lower and stabilize the Consumer Price Index (CPI) and Real Effective Exchange Rate (REER), among others.
