Request you to clarify. In case experience of assignments completed in only last 3 years is getting be considered for evaluation, request you to relax this criterion from 3 years to at least 10 years and substantially completed projects also to be considered for evaluation.</p> <p>Relaxation of this criteria from 3 years to at least 10 years is relevant as preparation and implementation of these national and regional level strategic plans are evolving through last decade and substantial experience of the same is relevant for this assignment.</p>	The criteria remains unchanged.
