1. Commentary on Consolidated Financial Statements

1.0 Legal Framework

Section 81 of the Public Finance Management (PFM) Act, 2012, requires that all state organs and public entities prepare annual financial statements at the end of each financial year and submit them to the Auditor-General with a copy to the National Treasury, Controller of Budget, and the Commission on Revenue Allocation before 30th September every year. Further, Section 80 of the PFM Act, 2012 requires the National Treasury to prepare annual financial statements that consolidate the financial statements of all national government entities and submit them to the Auditor-General, with a copy to the Controller of Budget and the Commission on Revenue Allocation, on or before 31st October of every year.

The consolidated financial statements referred to above are prepared in accordance with the standards prescribed by the Public Sector Accounting Standards Board (PSASB). The Board was established under Section 192 of the PFM Act, 2012, to set generally accepted accounting standards and prescribe formats for financial reporting by all state organs and public entities.

Following the Board's approval of the adoption of the International Financial Reporting Standards (IFRS) for state organs operating as commercial business entities, Accrual-basis International Public Sector Accounting Standards (IPSAS) for Ministries, Departments and Agencies (MDAs) and County Governments, and Accrual-basis IPSAS for state organs operating as non-commercial business entities, the reporting standards were gazetted through the Kenya Gazette Notice No. 11033 dated 30th August 2024.

Therefore, these consolidated financial statements are the First transition financial statements under the IPSAS accrual basis of accounting in line with IPSAS 33 and the transition roadmap adopted by the National Steering Committee. The first year of accrual accounting implementation requires all transitioning entities to recognize financial assets and liabilities on their balance sheets at a minimum. Those capable of recognizing more assets (including inventory and property, plant, and equipment) were permitted to do so. The transition period is expected to cover three years from 1st July 2024 to 30th June 2027.

1.1 Scope and Consolidation

The consolidated financial statements comprise eighty-one (81) voted entities, as contained in Executive Order No. 1 of 2023 on the Organization of the Government of the Republic of Kenya, and three (3) votes relating to Consolidated Fund Services (CFS). The entities included in this consolidation are disclosed in **Appendix 1** to the financial statements.

2. Financial Statements Summary

Below is an overview of the MDAs' financial performance for the year ended June 30th, 2025, as reported in the detailed consolidated financial statements.

3. Performance for Revenue and Expenses

This commentary should be read in conjunction with the financial statements hereunder. The Consolidated Financial Statements for Ministries, Departments, and Agencies for the year ended 30th June, 2025, have not been audited. Since this is the first transition year from cash accounting to accrual accounting, no comparative figures are provided on the Statement of Financial Performance. IPSAS 33 encourages but does not mandate comparative information in the first set of IPSAS financial statements.

Total Revenue for the FY 2024/2025 was Kshs 4,015 million against Total Expenses of Kshs. 4,538 million and Total Other gains/(losses) of (173,797) million resulting in a deficit of Kshs 696,929 million for the FY 2024/2025.

3.1 Revenue

The government revenue is derived from domestic and external sources. Domestic resources mainly comprise taxes collected by the Kenya Revenue Authority (KRA) and revenue from the appointed Receivers of Revenue. The National Treasury collects external sources, including loans and grants from multilateral and bilateral partners. All these revenues are then remitted to the Consolidated Fund as per Article 206 (1) of the Constitution, except revenue considered AiA.

Revenue reported in these consolidated financial statements is revenue that the MDAs received from the Consolidated Fund transfers (non-binding transactions) as per the Appropriation Act, 2024, and AiA (binding transactions) collected during the year. Funds transferred from the exchequer form the most significant part of MDA revenue, as shown below:

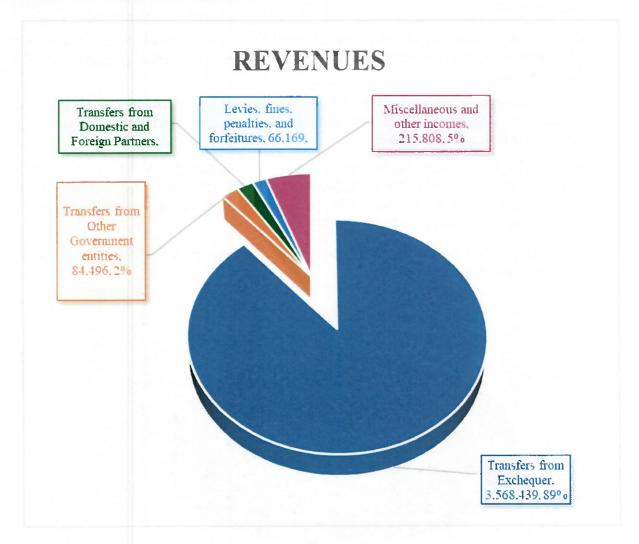

Miscellaneous income includes the sale of incidental goods, administrative fees, revenue from the sale of public assets, and own revenue collected and used directly as AIA. The total miscellaneous income for FY 2024/2025 was Kshs 159,807 million, representing 4% of the total revenue.

Transfers from the Consolidated Fund to MDAs were Kshs.3,568,439 million. This has been reconciled with amounts released by the Consolidated Fund for FY 2024/2025. The transfer primarily consists of tax revenue. Other revenues were collected through the e-Citizen platform and transferred to MDAs as AiA.

Further explanations on the above items are provided in their respective Notes to the Financial Statements.

The diagram below shows the share of the significant revenue categories for FY 2024/2025. The primary source of funding for the MDAs is transfers from the Consolidated Fund, which accounts for 89% of the total revenue.



3.2 Expenses incurred by MDAs

MDAs incur expenses in accordance with the Appropriation Act, 2024. Total expenses for the period ended 30th June 2025 stood at Kshs 4,538,729 million as shown below:

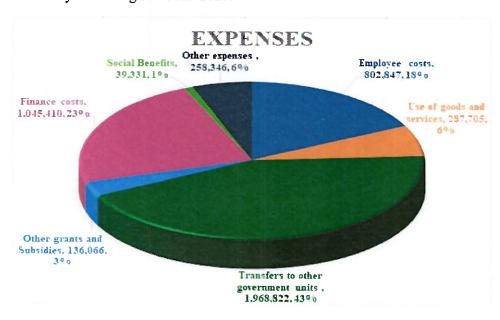

Employee costs consist solely of payroll payments and represent 18% of total expenses in FY 2024/2025. Total expenses include transfers to other government entities, grants and subsidies, and social benefits.

Transfer to other government entities refers to transfers made to state corporations and semiautonomous government agencies. These transfers have generally increased over the years as government activities have grown.

Payment of loan interest by the National Treasury stands at Kshs 1,045,410 million for the FY 2024/2025. The grace period for several concessional and commercial loans lapsed during the year. A detailed report on public debt is contained in a separate report as part of the Government Consolidated Financial Statements.

The diagram below shows the distribution of major expense categories for MDAs during the financial year ending 30th June 2025.



3.3 Financial Position

This being the first year of transition from cash to accrual accounting, the MDAs recognized only financial assets and financial liabilities as a minimum requirement in their financial reports. However, entities were encouraged to include physical assets acquired during the reporting period.

In particular, the Public Debt Management Office at the National Treasury included public debt as financial liabilities in the Statements of Financial Position as required by the transition to the accrual accounting roadmap. This resulted in a negative financial position of Kshs 11,953,408 million, as the corresponding assets are scheduled to be brought to the Statement of Financial Position progressively by FY 2026/2027.

The total assets for MDAs as at 30th June 2025 amounted to Kshs. 128,152 million compared to Kshs. 12,081,561 million as total liabilities, resulting in a total net liability of Kshs 11,953,408 million.

The total printed budget estimates, including AIA, amounted to Kshs 4,310,557 million. Funds disbursed through the exchequer and AIA collected and retained by the MDAs amounted to Kshs 4,001,626 million, indicating 93% budget estimate under achievement on receipts for the year ending 30th June 2025.

Payments were at 94% for both recurrent and development expenditure relative to the revised budgetary estimates.

5. Conclusion

The government has initiated various reforms to improve the integrity and timeliness of financial information generated, thereby enhancing decision-making for the prudent allocation and control of public resources.

The revenues and expenditures realized above reflect the Public Finance Management reforms currently being undertaken by the government of Kenya. These include transition to accrual accounting, IFMIS reengineering, Treasury Single Account, e-Citizen revenue systems, fiscal consolidation strategies, and debt sustainability strategy.

5. Statement of Responsibility

Section 80 (2) (a), (b), and (c) of the Public Finance Management (PFM) Act, 2012 requires the National Treasury to prepare annual consolidated financial statements that include:

- (a) a statement of all monies paid into and out of the National Exchequer Account;
- (b) a summary of -
 - (i) the appropriation accounts and statements prepared by accounting officers under section 81 of the Public Finance Management Act; and
 - (ii) statements prepared by receivers of revenue under section 82;
- (c) statement of payments made out of the National Exchequer Account that are authorized by legislation other than an Appropriation Act;

The Consolidated Financial Statements have been prepared on a going-concern basis and comply with IPSAS 33, First-time adoption of the Accrual basis of accounting, and with the format prescribed by the Public Sector Accounting Standards Board. These consolidated financial statements are based on individual financial statements prepared and submitted by respective Ministries, Departments, and Agencies (MDA) in accordance with Section 81 of the PFM Act, 2012. The responsibility of ensuring the accuracy and completeness of these individual financial statements rests with the Accounting Officers for the respective public entities.

The National Treasury is responsible for establishing and maintaining a system of internal control designed to provide reasonable assurance that transactions recorded are within statutory authority and that all public financial resources are appropriately recorded.

In our opinion, the transitional Consolidated Financial Statements for MDAs fairly reflect the consolidated financial position as at 30th June, 2025, and performance for the year ended on that date.

MDA's revenue against budget

- The original and revised estimates are based on the approved budget as loaded in the budget module of IFMIS. The actual outturn is based on unaudited financial statements submitted to the National Treasury for consolidation purposes. It is bound to change once the financial statements for all voted entities are audited.
- The changes between the original budget and final budget were a result of reallocations and additional appropriations through supplementary budgets that Parliament duly approved during the financial year ended 30th June 2025.
- The budget deficit of Kshs 62,900 million was partly attributed to an overdraft facility extended by the Central Bank of Kenya (CBK) to the Consolidated Fund Services (CFS) for public debt. A total of Kshs 51,900 million from this facility was applied towards the settlement of finance costs and the repayment of principal loans.
- During the year, the following votes received receipts on 'Transfer from other government entities' that were based on the budget of the sending entities:
 - (i) The State Department for Wildlife received Kshs 832 million from the Tourism Promotion Fund to promote wildlife conservation.
 - (ii) State Department for Performance and Delivery Management received Kshs 95 million from the Office of the Prime Cabinet Secretary to cater for the compensation of employees.
 - (iii) The Ministry of Defense received Kshs 92 million from CFS-Pensions and the Regional Defense Counter-Terrorism Center.
 - (iv) State Department for Roads received Kshs 71,126 million from the Kenya Roads Board relating to the Fuel Levy
- During the year, the State Department for livestock underperformed on receipts from the sale of goods (AIA) by 3% as a result of reduced AIA collection against the budgeted amount.

MDA's payments against budget

Capital expenditure Payment

- (i) Capital expenditure was below the target by 87% for the following state departments:
- (ii) State Department for Petroleum (71%) because of the late loading of the supplementary budget and time constraints to undertake procurement logistics.
- (iii) The State Department for the Environment absorbed 31% of the capital expenditure because of a decrease in the budget due to supplementary cuts.
- (iv) State Department for Medical Services absorbed 44% of Capital expenditure due to the delay of the procurement process for capital projects and the late release of development funds.

Grants and subsidies:

- Grants and subsidies were below the target by 79% for the following state departments:
 - (i) State Department for Petroleum 71% due to a delay in the disbursement process
 - (ii) Office of the Auditor General, 47% the underutilization was due to undisbursed funds by AfDB.
 - (iii) State Department for Agriculture, 71% the underutilization was due to a delay in the disbursement of donor funds

12. Notes to the Consolidated Financial Statements

12.1 Statement of compliance and the basis of Reporting. Statement of Compliance

These consolidated financial statements have been prepared following the accrual basis of International Public Sector Accounting Standards (IPSAS). They are in accordance with IPSAS, Section 80 (4) of the Public Finance Management Act 2012. These consolidated financial statements present fairly the financial transactions and financial position of the Government, as required by Article 226 of the Constitution and Section 80(4) of the Public Finance Management Act, 2012.

Where an IPSAS does not address a particular issue, the appropriate International Financial Reporting Standards (IFRSs) and International Accounting Standards (IASs) of the International Accounting Standards Board (IASB) have been applied.

12.2 Basis of Preparation

Section 80 of the Public Finance Management Act, 2012, mandates the National Treasury to prepare clear and comprehensible annual financial statements for the national government. These statements consolidate the financial statements of all national government entities, in formats prescribed by the Accounting Standards Board.

For this Consolidated Financial Statement, "budgetary central government consolidation" refers to the consolidation of Ministries, Departments, & Agencies, along with extra-budgetary units and National projects, as outlined in the Appropriation Act 2024.

These financial statements comply with International Public Sector Accounting Standards for the accrual basis of accounting. The measurement base applied is historical cost adjusted for revaluation of assets. The financial statements have been prepared on a going concern basis, and the accounting policies have been applied consistently throughout the period.

12.3 Reporting Period

The consolidated financial statements cover the financial year from 01 July 2024 to 30 June 2025, in accordance with IPSAS 1.63c and Article 260 of the Constitution of Kenya.

12.4 Reporting Currency

The financial statements are prepared in Kenya Shillings (Kshs.), which is the functional and reporting currency of the government, and all values are rounded to the nearest Kenya Shilling.

12.5 Basis of Consolidation

This consolidation is based on unaudited individual financial statements submitted by Ministries, Departments & Agencies (MDAs) to the office of the Auditor General on 30th August 2025, with copies to National Treasury, the Controller of Budget, and the Commission on Revenue Allocation. A revised consolidation based on audited financial statements will be prepared and submitted for audit purposes.

12.6 Elimination:

Material balances between entities included in this consolidation have been eliminated based on the inter-entity elimination template.

Significant Accounting Policies:

All consolidated entities have consistently applied the accounting policies set out in this section for the year presented. IPSAS requires accounting judgments to be made in determining accounting policies that impact the presentation of these financial statements. Most critical of these judgments, and their impact are:

Recognition of revenue

Revenue is an increase in the net financial position, other than increases arising from ownership contributions. Revenue must be measured when the event occurs and when the recognition criteria (probable inflow of resources and the ability to measure their value reliably) are met. Judgment is required to determine if these criteria are met, particularly where limited evidence is available at the time the revenue is earned.

Recognition of non-exchange expenses and liabilities

A liability is a present obligation of the *government* for an outflow of resources that results from a past event. Expenses (and other liabilities) are recognized when there is a present obligation (legal or constructive) as a result of a past event. An outflow of resources embodying economic benefits will probably be required to settle the obligation, and a reliable estimate of the obligation can be made. Judgment is required to assess each of these conditions and determine whether an expense and a present obligation should be reported.

The Government pursues several policy targets and outcomes. However, the commitment to these targets and outcomes generally does not, of itself, constitute a present obligation unless the government is transparent about the cost it intends to incur, when payment will be made, and to whom, and, as a consequence, has raised a valid expectation. As a consequence, liabilities are not reported for costs associated with the government policy objectives and targets. Where a policy choice gives rise to an obligation that exists independently of the government's future actions, expenses (and other related liabilities) are recognized for that policy.

Purpose and nature of financial instruments

Judgment is required to determine whether financial assets (including investments in securities and advances) and financial liabilities are held for trading or to provide a return through interest and principal transactions. Depending on that judgment, financial instruments will be reported at fair value or at amortized cost.

Climate change obligations

Kenya's current National Determined Contribution (NDC) to deliver on the goals of the Paris Agreement sets a headline target of a 32 per cent reduction in emissions by 2030 relative to the business-as-usual scenario, with a 143 MtCO2eq baseline. The government's commitment to climate change action does not constitute a present obligation on the balance sheet but is disclosed separately.

Physical assets

An asset is a resource presently controlled by the Government as a result of a past event. The primary reason for holding property, plant, and equipment and other assets is for their service potential rather than their ability to generate cash flows. Because of the services provided, a significant proportion of the assets used by public sector entities, including roads, national parks, heritage buildings, and other similar facilities, are specialized. There may be a limited market for such assets, so judgment is required in measuring them. Judgment is also required on whether assets are held for commercial purposes or public benefit purposes.

2. Recognition of Revenue

2.1 Revenue from non-binding arrangements

· Fees, taxes, and fines

The government recognizes revenues from fees, taxes, and fines when the event occurs and the asset recognition criteria are met. To the extent that there is a related condition attached that would give rise to a liability to repay the amount, deferred income is recognized instead of revenue. Other non-exchange revenues are recognized when it is probable that the future economic benefits or service potential associated with the asset will flow to the government and the fair value of the asset can be measured reliably.

• Transfers from other government entities

Revenues from non-exchange transactions with other government entities are measured at fair value and recognized on obtaining control of the asset (cash, goods, services, and property) if the transfer is free from conditions. It is probable that the economic benefits or service potential of the asset will flow to the government and can be reliably measured. Recurrent grants are

recognized in the statement of comprehensive income. Development grants are recognized in the statement of financial performance after meeting the revenue recognition criteria. Conditional grants are recognized as revenue upon fulfilment of the set conditions.

2.2 Revenue from binding arrangements

• Rendering of services

Revenue from rendering services is recognized by reference to the stage of completion when the outcome of the transaction can be reliably estimated. The stage of completion is measured by the percentage of labor hours incurred to date relative to the total estimated labour hours. When the contract outcome cannot be measured reliably, revenue is recognized only to the extent that the incurred expenses are recoverable.

Interest income

Interest income is accrued using the effective yield method. The effective yield discounts estimated future cash revenue through the expected life of the financial asset to that asset's net carrying amount. The technique applies this yield to the principal outstanding to determine interest income each period.

Rental income

Rental income arising from operating leases on investment properties is accounted for on a straight-line basis over the lease terms and included in revenue.

a) Budget information

The National Assembly approved the original budget for FY 2024/25 on 30th June, 2024. Subsequent revisions or additional appropriations were made to the approved budget in accordance with specific approvals from the appropriate authorities. The additional appropriations are added to the original budget by the MDA upon receiving the required approvals to finalize the budget. Accordingly, the MDA recorded additional appropriations of (Kshs 146,834,717,780) on the 2023/24 budget following the governing body's approval. The MDA's budget is prepared on a different basis from the actual income and expenditure disclosed in the financial statements. The financial statements are prepared on an accrual basis, with expenses classified by nature in the statement of financial performance. In contrast, the budget is prepared on a cash basis. The amounts in the financial statements were recast from the accrual basis to the cash basis and reclassified by presentation to be on the same basis as the approved budget.

A comparison of budget and actual amounts, prepared on a comparable basis to the approved budget, is then presented in the statement. In addition to the Basis difference, adjustments to amounts in the financial statements are also made for differences in the formats and classification schemes adopted for the presentation of the financial statements and the approved budget. A statement to reconcile the actual amounts on a comparable basis included in the statement of comparison of budget and actual amounts and the actuals as per the statement of cash flows has been presented under section xxx of these financial statements.

b) Investment property

Investment properties are measured initially at cost, including transaction costs. The carrying amount includes the replacement cost of components of an existing investment property at the time the cost is incurred, if the recognition criteria are met, and excludes the costs of day-to-day maintenance of an investment property. Investment property acquired through a non-exchange transaction is measured at its fair value at the date of acquisition. After initial recognition, investment properties are measured using the cost model and are depreciated in accordance with IPSAS 45 for that asset. Investment properties are derecognized either when they are disposed of or when they are permanently withdrawn from use and no future economic benefit or service potential is expected from their disposal. The difference between the net disposal proceeds and the carrying amount of the asset is recognized in the surplus or deficit in the period of derecognition. Transfers are made to or from investment property only when there is a change in use.

c) Property, plant and equipment

All property, plant, and equipment are stated at cost less accumulated depreciation and impairment losses. Cost includes expenditures directly attributable to the acquisition of the items. When significant parts of property, plant, and equipment are required to be replaced at intervals, the Entity recognizes such parts as individual assets with specific useful lives and depreciates them accordingly. Likewise, when a major inspection is performed, its cost is recognized in the carrying amount of the plant and equipment as a replacement if the recognition criteria are satisfied. All other repair and maintenance costs are recognized in surplus or deficit as incurred. Where an asset is acquired in a non-exchange transaction for nil or nominal consideration, the asset is initially measured at its fair value.

d) Right of use asset

The right-of-use assets comprise the initial measurement of the corresponding lease liability, lease payments made at or before the commencement day, less any lease incentives received and any initial direct costs. They are subsequently measured at cost less accumulated depreciation and impairment losses. Whenever the entity incurs an obligation for costs to dismantle and remove a leased asset, restore the site on which it is located, or restore the underlying asset to the condition required by the terms and conditions of the lease, a provision is recognized and measured under IPSAS 21 or IPSAS 26. To the extent that the costs relate to a right-of-use asset, the costs are included in the related right-of-use asset, unless those costs are incurred to produce inventories. Right-of-use assets are depreciated over the shorter of the lease term and the underlying asset's useful life. Suppose a lease transfers ownership of the underlying asset or the cost of the right-of-use asset reflects that the Entity expects to exercise a purchase option. In that case, the related right-of-use asset is depreciated over the useful life of the underlying asset. Depreciation begins on the lease commencement date. The right-of-use assets are presented as a separate line in the statement of financial position.

e) Tangible Natural Resources

The entity recognizes a tangible natural resource is recognized if, and only if: It is probable that service potential associated with the natural resource will flow to the Entity; the Entity controls the tangible natural resource as a result of past events; and the tangible natural resource can be measured reliably. Where this criterion is not met, the Entity discloses the tangible natural resource in the notes to the financial statements. Where a tangible natural resource is recognized as an asset as the result of an event that is not a transaction in an orderly market, including non-exchange transactions, the asset shall be measured initially at its deemed cost. An Entity shall apply IPSAS 46, Measurement, when measuring the deemed cost of such a recognized tangible natural resource. A recognized tangible natural resource acquired through an exchange transaction shall be measured at its cost. The historical cost model is applied after initial recognition, less any depreciation and impairment losses.

f) Leases

Finance leases are leases that transfer substantially all of the risks and benefits incidental to ownership of the leased item to the Entity. Assets held under a finance lease are capitalized at the commencement of the lease at the fair value of the leased property or, if lower, at the present value of the future minimum lease payments. The Entity also recognizes the associated lease liability at lease inception. The liability recognized is measured as the present value of the future minimum lease payments at initial recognition. After initial recognition, lease payments are apportioned between finance charges and the reduction of the lease liability to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are recognized as finance costs in surplus or deficit. An asset held under a finance lease is depreciated over its useful life. However, suppose there is no reasonable certainty that the Entity will obtain ownership of the asset by the end of the lease term. In that case, the asset is depreciated over the shorter of its estimated useful life and the lease term.

g) Intangible assets

Intangible assets acquired separately are initially recognized at cost. The cost of intangible assets acquired in a non-exchange transaction is their fair value at the date of the exchange. Following initial recognition, intangible assets are carried at cost less any accumulated amortization and accumulated impairment losses. Internally generated intangible assets, excluding capitalized development costs, are not capitalized, and expenditure is reflected in surplus or deficit in the period in which the expenditure is incurred. The useful life of the intangible assets is assessed as either finite or indefinite.

h) Research and development costs

The MDA expenses research costs as incurred. Development costs on an individual project are recognized as intangible assets when the entity can demonstrate:

- i) The technical feasibility of completing the asset so that the asset will be available for use or sale
- ii) Its intention to complete and its ability to use or sell the asset
- iii) How the asset will generate future economic benefits or service potential
- iv) The availability of resources to complete the asset
- v) The ability to measure reliably the expenditure during development.

Following initial recognition of an asset, the asset is carried at cost less any accumulated amortization and accumulated impairment losses. Amortization of the asset begins when development is complete, and the asset is available for use. It is amortized over the period of expected future benefit. During the period of development, the asset is tested for impairment annually, with any impairment losses recognized immediately in surplus or deficit.

i) Financial instruments

IPSAS 41 addresses the classification, measurement, and derecognition of financial assets and financial liabilities, introduces new rules for hedge accounting, and a new impairment model for financial assets. The entity does not have any hedge relationships and therefore the new hedge accounting rules have no impact on the Company's financial statements. (amend as appropriate). A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another Entity. At initial recognition, the Entity measures a financial asset or financial liability at its fair value plus or minus, in the case of a financial asset or financial liability not at fair value through surplus or deficit. These transaction costs are directly attributable to the acquisition or issue of the financial asset or financial liability.

A. Financial assets

Classification of financial assets

The government classifies its financial assets as subsequently measured at amortized cost, fair value through net assets/equity, or fair value through surplus and deficit, based on both the government's management model for financial assets and the contractual cash flow characteristics of the financial asset. A financial asset is measured at amortized cost when the financial asset is held within a management model whose objective is to hold financial assets to collect contractual cash flows, and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal outstanding. A financial asset is measured at fair value through net assets/ equity if it is held within the management model whose objective is achieved by both collecting contractual cash flows and selling financial assets. The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. A financial asset shall be measured at fair value through surplus or deficit unless it is measured at amortized cost or fair value through net assets/ equity unless a government has made an irrevocable election at initial recognition for particular investments in equity instruments.

Subsequent measurement

Based on the business model and cash flow characteristics, the Entity classifies its financial assets into amortized cost or fair value categories. Movements in fair value are presented either as a surplus or a deficit, or through net assets/equity, subject to specific criteria being met.

Amortized cost

Financial assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest, and that are not designated at fair value through surplus or deficit, are measured at amortized cost. A gain or loss on an instrument measured at amortized cost and not part of a hedging relationship is recognized in profit or loss when the asset is derecognized or impaired. Interest income from these financial assets is included in finance income using the effective interest rate method.

Fair value through net assets/ equity

Financial assets held for collection of contractual cash flows and for sale, where the assets' cash flows represent solely payments of principal and interest, are measured at fair value through net assets/equity. Movements in the carrying amount are taken through net assets, except for the recognition of impairment gains or losses, interest revenue, and foreign exchange gains and losses, which are recognized in surplus/deficit. Interest income from these financial assets is included in finance income using the effective interest rate method.

Trade and other receivables

Trade and other receivables are recognized at fair values less allowances for any uncollectible amounts. Trade and other receivables are assessed for impairment on a continuing basis. An estimate of doubtful receivables is based on a review of all outstanding amounts at year-end.

Fair value through surplus or deficit

Financial assets that do not meet the criteria for amortized cost or fair value through net assets/ equity are measured at fair value through surplus or deficit. A business model in which the government manages financial assets solely to realize cash flows from their sale would result in a fair value through surplus or deficit model.

Impairment

The government assesses, on a forward-looking basis, the expected credit loss ('ECL') associated with its financial assets carried at amortized cost and fair value through net assets/equity. The government recognizes a loss allowance for such losses at each reporting date. Critical estimates and significant judgments made by management in determining the expected credit loss (ECL) are set out in *Note xx*.

B. Financial liabilities

Classification

The government classifies its liabilities as subsequently measured at amortized cost except for financial liabilities measured through profit or loss.

j) Inventories

Inventory is measured at cost upon initial recognition. To the extent inventory was received through non-exchange transactions (at no or nominal cost), its cost is its fair value at the date of acquisition. Expenses incurred in bringing each product to its present location and conditions are accounted for, as follows:

- i) Raw materials: purchase cost using the weighted average cost method.
- ii) Finished goods and work in progress: cost of direct materials and labor, and a proportion of manufacturing overheads based on the standard operating capacity, but excluding borrowing costs.

After initial recognition, inventory is measured at the lower of cost and net realizable value. However, to the extent that a class of inventory is distributed or deployed at no charge or for a nominal charge, that class of inventory is measured at the lower of cost and current replacement cost. Net realizable value is the estimated selling price in the ordinary course of operations, less the estimated costs of completion and the estimated costs necessary to make the sale, exchange, or distribution. Inventories are recognized as an expense when deployed for use or consumption in the ordinary course of government operations.

k) Provisions

Provisions are recognized when the Entity has a present obligation (legal or constructive) as a result of a past event, an outflow of resources embodying economic benefits or service potential will probably be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation. Where the Entity expects some or all of a provision to be reimbursed — for example, under an insurance contract —the reimbursement is recognized as a separate asset only when it is virtually certain. The expense relating to any provision is presented in the statement of financial performance net of any reimbursement.

1) Social Benefits

Social benefits are cash transfers provided to i) specific individuals and/or households that meet the eligibility criteria, ii) mitigate the effects of social risks, and iii) address the needs of society as a whole. The entity recognizes a social benefit as an expense for the social benefit scheme while simultaneously acknowledging a liability. The liability for the social benefit scheme is measured at the best estimate of the cost (the social benefit payments) that the entity will incur in fulfilling the present obligations represented by the liability.

m) Contingent liabilities

The entity does not recognize a contingent liability but discloses details of any contingencies in the notes to the financial statements, unless the possibility of an outflow of resources embodying economic benefits or service potential is remote.

n) Contingent assets

The entity does not recognize a contingent asset but discloses details of a possible asset whose existence is contingent on the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the entity in the notes to the financial statements. Contingent assets are assessed continually to ensure that developments are appropriately reflected in the financial statements. Suppose it has become virtually certain that an inflow of economic benefits or service potential will arise, and the asset's value can be measured reliably. In that case, the asset and the related revenue are recognized in the financial statements of the period in which the change occurs.

o) Nature and purpose of reserves

The entity creates and maintains reserves in terms of specific requirements.

p) Changes in accounting policies and estimates

The MDA recognizes the effects of changes in accounting policy retrospectively. The impact of changes in accounting policy is applied prospectively if retrospective application is impractical.

q) Employee benefits

Retirement benefit plans

The MDA provides retirement benefits for its employees and directors. Defined contribution plans are post-employment benefit plans under which an MDA pays fixed contributions into a separate fund. They will have no legal or constructive obligation to pay further contributions if the fund does not hold sufficient assets to pay all employee benefits relating to employee service in the current and prior periods. Contributions to fund obligations for the payment of retirement benefits are charged to income in the year in which they become payable. Defined benefit plans are post-employment benefit plans other than defined-contribution plans. The defined benefit funds are actuarially valued under the projected unit credit method. Deficits identified are recovered through lump-sum payments or, on a proportional basis, increased future contributions for all participating employers. The contributions and lump sum payments reduce the post-employment benefit obligation.

r) Foreign currency transactions

Transactions in foreign currencies are initially recorded at the exchange rate prevailing on the transaction date. At each reporting date, foreign currency monetary items are translated using the closing rate. Non-monetary items measured in historical cost are translated using the exchange rate at the transaction date, and those measured at fair value are translated using the exchange rate at the date the fair value was determined. Exchange differences arising from the settlement of monetary items or translation of monetary/non-monetary items at rates different from those at which they were initially reported are recognized in surplus or deficit in the period.

s) Borrowing costs

Borrowing costs are capitalized against qualifying assets as part of property, plant, and equipment.

Such borrowing costs are capitalized over the period during which the asset is being acquired or constructed and borrowings have been incurred. Capitalization ceases when the asset is constructed. Further borrowing costs are charged to the statement of financial performance.

t) Related parties

The MDA regards a related party as a person or an MDA that can exert control individually or jointly, or exercise significant influence over the MDA, or vice versa. Members of key management are considered related parties and include the directors, the CEO, and senior managers.

u) Service concession arrangements

The MDA analyses all aspects of service concession arrangements it enters into to determine the appropriate accounting treatment and disclosure requirements. In particular, where a private party contributes an asset to the arrangement, the MDA recognizes that asset only when it controls or regulates the services the operator must provide with the asset, to whom it must provide them, and at what price.

In the case of assets other than 'whole-of-life' assets, it controls, through ownership, beneficial entitlement or otherwise, any significant residual interest in the asset at the end of the arrangement. Any assets so recognized are measured at their fair value. To the extent an asset has been recognized, the MDA also recognizes a corresponding liability, adjusted for cash consideration paid or received.

v) Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and cash at bank, short-term deposits on call, and highly liquid investments with an original maturity of three months or less, which are readily convertible to known amounts of cash and are subject to insignificant risk of changes in value. Bank account balances include amounts held at the Central Bank of Kenya and at various commercial banks at the end of the financial year.

w) Comparative figures

In preparing these financial statements, the MDA has elected to apply paragraph 79 of IPSAS 33, which allows for the election by an MDA to present one statement of financial performance, one statement of cash flow, one statement of net assets and the statement of financial position and an opening statement of financial position as at the time of first-time adoption of the accrual basis of accounting.

x) Subsequent events

There have been no events subsequent to the financial year-end with a significant impact on the financial statements for the year ended June 30, 2025

Significant Judgments and Sources of Estimation Uncertainty

The preparation of the MDA's financial statements in conformity with IPSAS requires management to make judgments, estimates, and assumptions that affect the reported amounts of revenues, expenses, assets, and liabilities, as well as the disclosure of contingent liabilities at the end of the reporting period. However, uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of the asset or liability affected in future periods.
