## THE PUBLIC FINANCE MANAGEMENT ACT

(Cap. 412A)

**IN EXERCISE** of the powers conferred by section 24(4) of the Public Finance Management Act, the Cabinet Secretary for the National Treasury and Economic Planning makes the following Regulations—

## THE PUBLIC FINANCE MANAGEMENT (PUBLIC OFFICERS MEDICAL SCHEME FUND) (AMENDMENT) REGULATIONS, 2025

Citation.

**1.** These Regulations may be cited as the Public Finance Management (Public Officers Medical Scheme Fund) (Amendment) Regulations, 2025.

- **2.** Regulation 2 of the Public Finance Management (Public Officers Medical Scheme Fund) Regulations, 2024, is amended by inserting the following new paragraphs:
  - "National Police Service Commission" means the National Police Service Commission established by Article 246 of the Constitution;
  - Under the interpretation of "public officer" insert a new (c)recruited and employed by the Teachers Service Commission; or

**3.** Delete Regulation 10 (1) and replace it with the following paragraph.

A Board is established to be known as the Public Officers Medical Scheme Fund Board. The Board shall consist of:

- a) Chief of Staff and Head of Public Service Chairman
- b) Principal Secretary/ National Treasury
- c) Principal Secretary/ Medical Services
- d) Principal Secretary/Public Service
- e) Accounting Officer/Teachers' Service Commission
- f) Accounting Officer/National Police Service
- g) Chief Executive Officer/ Council of Governance

**4.** On Regulation 11 (1), delete the whole sub-regulation and replace it with the following:

- (a) two representatives of the Ministry responsible for public service;
- (b) two representatives of the Social Health Authority, one of whom shall be the CEO and the other from the unit responsible for the management of the Fund and the associated benefits package;
- (c) a representative of the Ministry responsible for finance;
- (d) a representative of the Office of the Attorney-General;
- (e) a representative of the Inspector General National Police Service;
- (f) a representative of the Commission Secretary of the Teachers Service Commission;
- (g) a representative of the Council of Governors; and
- (h) four persons, one each nominated by the Union of Kenya Civil Servants, Kenya National Union of Teachers, Kenya Union of Post-Primary Education Teachers, and Kenya Medical Practitioners, Pharmacists and Dentists Union.
